#### KEY CHANGES IN INCOME TAX RETURN FORMS FOR A.Y. 2021-22

CBDT has notified the new ITR forms applicable for AY 2021-22 vide Notification No. 21/2021, dated 31.03.2021. No significant changes are made in the ITR Forms this year as compared to last year's Forms considering the Covid pandemic. Most of the changes are to give effect to the amendments made in the Finance Acts and to bring out more transparency in the returns.

### CHECKLIST FOR RENEWAL OF 12A & 80G CERTIFICATE FOR NPO/TRUSTS

In view of the amendment made in the Income-tax Act, 1961, all the companies/trusts which are registered under section 12A and 80G, are required to get themselves re-registered by filing Form on the IT portal by 30/06/2021.

### STEPS FOR UPDATING THE IMPORTER-EXPORTER CODE (IEC)

As per the recent DGFT Notification Number 58 dated 12.02.2021, any Importer - Exporter Code (IEC) Holder is required to update their IEC electronically every year, during the period of April to June. While this updation is mandatory, due consideration has been taken not to increase any compliance burden. It may be noted that IEC updation is online and automated. Further, there are no user charges to be paid for such IEC updation. Let us follow steps mentioned in this article for easy guidance on updating IEC details through the automatic DGFT online process.
